In the Nick of Time

BVMI's female patients "hold their families up" in many ways: physically, emotionally, and financially. When they're ill, everyone suffers. Our team works every day to keep women well, for their sakes and for those they care about.

Every patient has a story to tell. Sarah's is one that brings us relief and gratitude. Unable to afford healthcare when she arrived in the U.S., Sarah learned about BVMI from a friend. Through our Women's Health Initiative, she received a routine mammogram. The results were not what she'd hoped.

"The day BVMI shut down because of COVID, I got a call from Holy Name Medical Center," said Sarah. "Based on my mammogram results, I needed a biopsy. Then the biopsy showed I had breast cancer, and needed surgery. I couldn't afford that, so BVMI helped me find the resources I needed. They provided interpreters and arranged appointments for me. They even screened me for depression, and provided mental health support."



Gaining Independence

Helena, a BVMI patient and single parent was underemployed, working long hours at low-paying jobs. BVMI's Case Management program helped her find food and rental assistance. But Case Manager Rosa wanted to do more for Helena and others like her. She contacted the Women's Rights Information Center and Bergen County Job Center, and they covered the cost of certified Home Health Aide training for Helena and a few other BVMI female patients. Helena took a financial risk, reducing her work hours in order to study. It paid off. She passed her exams! Now a certified Home Health Aide with a reputable program, Helena is empowered and hopeful in her new career.

Two-thirds of BVMI's patients are women, nearly 900 in all. In addition to primary care, each receives an annual well-woman exam through the Women's Health Initiative. All women over the age of 40 are referred out for an annual mammogram.

I don't know what would have happened to me, and then to my family, if I hadn't found BVMI.

"My cancer was caught early, while it was treatable," said Sarah. My friend who referred me to BVMI has had uterine and breast surgery, too. We agreed that if we're ever able, we'll donate to BVMI. They are like friends and family, and have done so many things for us."



Without BVMI, nearly 900 women living in poverty would have no recourse for ongoing care.
