There were just 12 ER visits for every 100 BVMI patients, compared to the national average of 35 ER visits per 100 uninsured individuals. With just one average ER visit costing \$2,683, this reduction in visits resulted in estimated savings of over \$630,000 for the local Bergen County safety net in 2025.

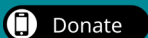
